There is a housing crisis in Columbia County. We have jobs, but *no housing that most average-wage workers can afford*. This is taking a toll on the businesses and organizations - like you - who call Columbia County home, because current and prospective employees cannot afford to live here.

If the people who teach our children, work our farms, serve our coffee, draw our blood, maintain our streets, fight fires, and staff our offices cannot find or afford housing in our communities, they leave for places where they can affordably raise their children. We see this in the declining school enrollment, and the county's demographic trends.

Columbia County Habitat for Humanity is gearing up to create more housing. In May, *we broke ground on two new homes* in the Village of Philmont. We

recognize that we must do more...and do it at a scale that will have a measurable effect on the current housing crisis. We are preparing to build more homes more often, and are asking for your support to help make that happen.

We will soon be unveiling **a new building program to create more safe, efficient & affordable starter homes** for those who make our communities work. Several Columbia County municipalities are already actively supporting this effort by working with us to find suitable building sites.
